This custom foal contract is for the Friesian mare **Lara F.Q.** to be bred to the stallion
named _____.

BOTH PARTIES AGREE TO THE FOLLOWING TERMS AND PROVISIONS

1. This agreement includes a live foal guarantee that covers the stud fee until the mare has produced a live, standing and nursing foal.
2. Stallion selection is at the preference of the buyer, final approval by mare owner.
3. This agreement covers a stud fee of up to \$1,800.
4. The mare will remain in the custody of NorthCreek Friesians.
5. The foal will be the legal responsibility of the buyer as of the day it is born.
6. Boarding until weaning (3 months) is included in this contract.
7. Foal owner is strongly advised to obtain insurance on the foal until it is safely transported to his/her home.
8. This foal contract is non-refundable unless the mare fails to produce a live foal.
9. The foal owner agrees to provide NorthCreek Friesians with digital pictures of the foal as a yearling. NorthCreek Friesians reserves the right to use these pictures for further promotion of their farm.

FEES PAYABLE TO NORTHCREEK FRIESIANS

- custom foal contract fee: \$4,950, payable at time of contract signing
- stud fee difference if stallion chosen is more than \$1,800
- forms of payment accepted: cash, personal check or money order

NAMING AND REGISTRATION OF THE FOAL

Naming and registration of the foal will be the responsibility of the foal owner. NorthCreek Friesians *requests* that the name chosen by the owner include the initials NC after it to identify it as our offspring. According to FHANA rules, for registration in the year 2014, the foal's name must begin with the letter T, U or V.

TRANSFER

This agreement is not assignable to any third party not named in this agreement, without the prior approval of NorthCreek Friesians.

GOVERNING LAW

This breeding contract shall be governed by and construed in accordance with the laws of the state of **IOWA**.
